## RULES, REGULATIONS, & PARKS COMMITTEE MEETING MINUTES AUGUST 13, 2025

This meeting was called to order at 6pm by Chairman Jennifer Priesgen.

Attendance: Jessica Loomans, Gary More, Jennifer Priesgen

Public Attendance: Leah Henckel of the Dodge County Pionier, Codey Braatz of the DCSO, Nick Roskopf, Jenna Rhein

The Committee discussed setting requirements for selling equipment, vehicles, trailers, camper, recreational vehicles, etc on residential lots. WI DoT permits up to five vehicles per year by owner. The committee agreed to permit up to three items per year per parcel as long as the items are placed on an improved surface no longer than 30 consecutive days per calendar year per property. Sales cannot be on Village streets or property. Jenna Rhein will create an ordinance and the committee will review prior to presenting it to the Board.

Next, the ordinance regarding weed and snow notices was reviewed. The current ordinance states a notice has to be provided to the property owner to maintain the weeds/grass/snow, and if not fixed within a certain time frame, then the DPW will cut/plow and the expense is billed to the property owner. Jenna Rhein reported that this process is very time-consuming, some property owners are repeat offenders, and it may be beneficial for the Village to provide one notice in writing to the offenders, instead of multiple notices. The committee agreed to update the ordinance.

Jenna Rhein reported that the revenue generated by the sale of cat licenses does not outweigh the cost of the licenses. Each year, the cost for cat licenses is approximately \$100. There are many residents that don't license their cats and the ordinance states the Village does not acknowledge stray cats. The committee agreed to remove the regulation of cat licenses from the ordinance.

The schedule of fees was reviewed. Due to time constraints, the committee will revisit the schedule at another meeting to allow for more discussion.

Meeting adjourned at 6:51pm.
