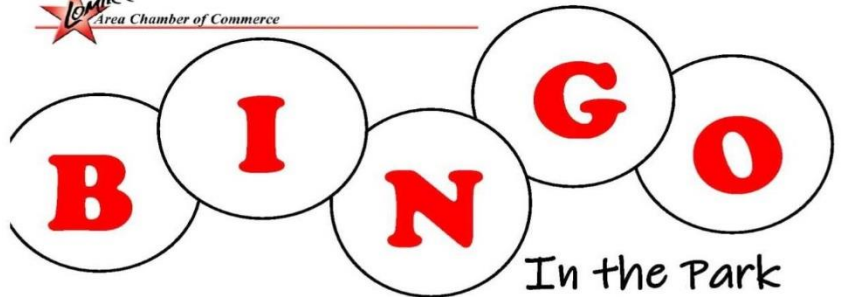

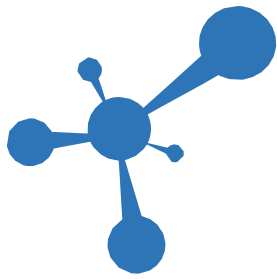

Dodge County Sheriff's Office Newsletter

With warmer weather upon us and more opportunities for the residents of Lomira to be out and about, or have parties and get-togethers, I thought there are some ordinances residents should be aware of. I'd like to take this opportunity to educate everyone about some of the village ordinances you may not be aware of. The Village ordinances can be viewed at

ATV and UTV Regulations:

The summer weather is a great time to take advantage of driving ATV/UTVs on the village roadways. You may not be aware of ordinances that restrict who, when, and where they can be legally operated.

For instance, LM22-117(1): In accordance with WI Stats. § 23.33(8)(b)2 and unless otherwise posted, all streets, roads and public alleys within the village are designated ATV and UTV routes, except all county highways, state trunk highways or connecting highways with a speed of 35 miles per hour or greater, unless the applicable county or state authority approves such a designation

Also, LM22-119 states 1.) All ATV and UTV operators will observe posted speed limits; not to exceed 35 miles per hour; 2) All ATV and UTV units shall be registered for public use in accordance with the WI DNR regulations, and proof of registration shall be displayed as required by statute during all times of operation; 3) No person under 18 years of age may operate or be a passenger on an ATV or UTV without wearing protective headgear of the type required under Wis. Stats. § 347.485(1)(a) and with the chin strap properly fastened, except as specifically exempted under Wis. Stats. § 23.33(b)(c)(d); 4) ATV and UTV use is prohibited in the village between the hours of 11:00 p.m. and 6:00 a.m. unless the unit is licensed for agricultural use; 6) No person shall operate an ATV or UTV unless the operator is 16 years of age or older and holds a valid driver's license issued by the state department of transportation, or another state driver's licensing authority; 7) No person shall operate an ATV or UTV within any municipal park or on any sidewalk, designated bicycle or pedestrian lane, gravel shoulder, ditch or other area of any street right-of-way other than on the paved roadway, unless specifically designated and posted otherwise by the village or its designee. Parking lots designed for normal traffic for parks, playgrounds, or other municipal utilities are allowable for UTV/ATV traffic, as long as the machine does not leave the paved or gravel surface; 8) The operator of an ATV or UTV will display a lighted headlamp and tail lamps on the ATV or UTV and display the registration or license plate at all times; 9) No person shall operate an ATV or UTV within the village unless the owner or operator has in effect at the time a liability policy insuring operation of the ATV or UTV which policy meets the carrier and coverage requirements specified in WI.Stats. § 344.61. No person shall operate an ATV or UTV without having proof of such liability insurance coverage readily available.

Fireworks Regulations:

We're all excited about the July 4th holiday approaching, which may include the use of fireworks. Village ordinance adopts the State laws regarding the sale, transport, and use of fireworks. While it is legal for individuals to purchase, transport, and possess firework(s) within the Village (as long as they are purchased with a Village permit from the local store), the use of them is limited.

Regulation LM12-273(b) defines firework(s) as the following:

Fireworks mean anything manufactured, processed, or packaged for exploding, emitting sparks, or combustion which does not have another common use, but does not include any of the following:

- (1) Fuel or lubricant.
- (2) A firearm cartridge or shotgun shell.
- (3) A flare used, possessed, or sold for use as a signal in an emergency or in the operation of a railway, aircraft, watercraft, or motor vehicle.
- (4) A match, cigarette lighter, stove, furnace, candle, lantern, or space heater.
- (5) A cap containing not more than one-quarter grain of explosive mixture, if the cap is used or possessed or sold for use in a device that prevents direct bodily contact with a cap when it is in place for explosion.
- (6) A toy snake that contains no mercury.
- (7) A model rocket engine.
- (8) Tobacco and a tobacco product.

- (9) A sparkler on a wire or wood stick not exceeding 36 inches in length that is designed to produce audible or visible effects or to produce audible and visible effects.
- (10) A device designed to spray out paper confetti or streamers which contains less than one-quarter grain of explosive mixture.
- (11) A fuse-less device that is designed to produce audible or visible effects or audible and visible effects, and that contains less than one-quarter grain of explosive mixture.
- (12) A device that is designed primarily to burn pyrotechnic smoke-producing mixtures, at a controlled rate, and that produces audible or visible effects, or audible and visible effects.
- (13) A cylindrical fountain that consists of one or more tubes and that is classified by the federal Department of Transportation as a division 1.4 explosive, as defined in 49 CFR 173.50.
- (14) A cone fountain that is classified by the federal Department of Transportation as a division 1.4 explosive, as defined in 49 CFR 173.50.
- (15) A novelty device that spins or moves on the ground.

Please note that even if you have the permit to possess the firework(s) within the Village, the following designates what is required to be able to use (shoot) them:

LM12-273(d)(1): No person may possess fireworks without a Village possession permit from the Village President or from an official or employee of the Village as may be designated by the President. No person may use fireworks or a device listed under subsection (b)(5) to (7) or (9) to (14) while attending a fireworks display for which a permit has been issued to a person listed under subsection (b)(1) to (5) of this section or under subsection (b)(6) of this section if the display is open to the general public. What this means is, unless you are able to purchase a permit from the Village to shoot the fireworks, you are not legally allowed to use them within the village limits.

The following is what is required to obtain a permit (to use/shoot fireworks) from the Village:

LM12-273(d)(3) states: A permit under this subsection may be issued only to the following:

- a. A public authority
- b. A fair association
- c. An amusement park
- d. A park board
- e. A civic organization
- f. Any individual or group of individuals. A permit issued to a group of individuals confers the privileges under the permit to each member of the group.
- g. An agricultural producer for the protection of crops from predatory birds or animals

Further, LM12-273(d)(5) states: The Village, when issuing a permit under this subsection, may require an indemnity bond with good and sufficient sureties or policy of liability insurance for the payment of all claims that may arise by reason of injuries to person or property from the handling, use or discharge of fireworks under the permit. The bond or policy, if required, shall be taken in the name of the Village wherein the fireworks are to be used, and any person injured thereby may bring an action on the bond or policy in the person's own name to recover the damage the person has sustained, but the aggregate liability of the surety or insurer to all persons shall not exceed the amount of the bond or policy. The bond or policy, if required, together with a copy of the permit shall be filed in the office of the Village Administrator-Clerk-Treasurer.

Also, LM12-273(d)(6) states: A permit under this subsection shall specify all of the following:

- a. The name and address of the permit holder.
- b. The date on and after which fireworks may be purchased.
- c. The kind and quantity of fireworks that may be purchased.
- d. The date and location of the permitted use.
- e. Proof of \$2,000,000.00 liability insurance.

LM12-273(g): Parental liability. A parent, foster parent, treatment foster parent, family-operated group home parent, legal guardian of a minor, or other out-of-home care providers, as defined in Wis. Stats. § 48.02(12r), who consents to the use of fireworks by the minor is liable for damages caused by the minor's use of the fireworks.

LM12-273(h)(3): A parent or legal guardian of a minor who consents to the use of fireworks by the minor shall forfeit not more than \$1,000.00.

In conclusion, this means that unless you get a permit to shoot off firework(s) from the Village if you use them, you are subject to being issued a citation. There are other provisions in the local ordinances and State laws, so it is recommended you review them before you purchase or use any firework(s).

Overall, this information has been put together as an educational tool for you. There are numerous other ordinance subsections related to ATV/UTV and firework(s) that should be reviewed on the website to hopefully avoid being in violation and possibly being issued citations.



Sewer charges are based on water used. Minimum sewer charge per quarter is \$26.02. The charge is calculated by multiplying the total number of gallons of water used by \$12.70/1000 plus a service charge of \$26.02.

QUARTERLY UTILITY BILLS

Utility bills are due by the date printed on the bill and become delinquent on the next day after due date. Delinquent charges will be assessed in the amount of 3%. Minimum penalty is \$.50. In the event the sewer and water bill remains unpaid after due date, there will be a past due/disconnection notice. Water service reconnection fee is \$30.
