This meeting was called to order by Chairman Jennifer Priesgen.

The committee discussed the vision clearance triangle at intersections to include a better detailed picture. Nick Roskopf presented a picture the City of Neenah has in their ordinances. The picture is easier to follow and understand. Jennifer Priesgen recommended the vision triangle be set to 25' by 25' clearance. Nick Roskopf will create an updated picture for the ordinance book.

The sideyard setback and structural overhang maximum widths were discussed. The typical residential overhang width is 2' and the minimum sideyard setback is 12' from foundation to lot line. After further research, Gary More did not find information in other municipal codes or NFPA-1 standards. The committee would like to see the ordinance revised to include the Director of Public Works or the Fire Department Chief sign off on any overhang building permits.

This meeting was called to order at 7:30pm by President Donald Luedtke.

Motion by Tr. Pribnow, seconded by Tr. Kohlmann to approve the agenda as presented. Motion carried.

Motion by Tr. Ritger, seconded by Tr. Loomans to dispsense reading of the previous meeting minutes and approve as emailed. Motion carried.

Deb Janke, Carol Knuth, John Krentz and Dino Claraco presented concerns regarding the police services, contracting police services with the Village of Theresa and contracting police services with Dodge County. Tr. Kohlmann reported there was a possible interest in contracting with Dodge County to explore all possible options of services and was intrigued because other municipalities were also exploring that option. There has been no movement on such topic with Dodge County and therefore, the Village is not pursuing anything with Dodge County.

Motion by Tr. Ritger, seconded by Tr. Kohlmann to cease police service discussions at the moment with the Village of Theresa. Motion carried. Tr. Ritger reported the Fire & Police Committee recommended to cease discussions due to other internal issues that need to be resolved. The Village has budgetary constraints that need to be fixed before a new contract can be developed. Tr. Kohlmann also expressed that negotiations with the PD union are ongoing and therefore, would be irresponsible of the Village to offer services for another municipality when the Village doesn't have business in order.

Motion by Tr. Ritger, seconded by Tr. More to table consideration of crack sealing projects for portions of Main Street, Third Street, Fourth Street and Willow Street and have the Streets committee meet to discuss purchasing crack sealing equipment. Motion carried. Nick Roskopf reported that since the Public Works department is down one laborer, it will not be feasible for the crew to perform road crack sealing. Tr. Ritger suggested the Village utilize \$14-16,000 to purchase equipment and train the crew to do in-house crack sealing.

Chief Frank provided an update on the new squad truck that was ordered in 2021. The truck will be delivered to Ewald the week of July 5. In addition, an extended warranty on the vehicle is offered through Van Horn with \$500 below their cost. The warranty will be 8-year, 100,000 miles. There is no plan for putting graphics on the vehicle yet and priority will be to get the equipment installed first.
